1. Scope

These terms and conditions apply to new fee-paying full-time Taught Postgraduate Master's students taking up a place of study in 2025/26 entry, who are identified by the University as eligible for consideration for one of the Taught Postgraduate Master's Scholarships. They specifically apply to students from the three Faculties: Science, Engineering & Design, and Humanities and Social Sciences.

Please note that there are other scholarships schemes for fee-paying Taught Postgraduate Master's students in the School of Management which have separate guidelines. Please see University of Bath website for full details.

The allocation of the scholarship is competitive and so not all applications received may be successful. Please see below for details on how selection is made.

Scholarships are awarded in the form of a fee waiver ('discount') which is a sum of money to assist fee-paying students with tuition fees. The University allocates a waiver to your fee account in place of some of the fee liability you would otherwise have. The fee waiver is applied to your first year of study only. There is no cash alternative to a fee waiver. Scholarships cannot be deferred and are for the 2025/26 academic entry year only. Eligible candidates will be invited to apply for a scholarship by the International Student Recruitment Office.

This document outlines the full terms and conditions of this scheme and you should read these before you accept your scholarship.

2. Eligibility

If you wish to be considered for one of the Taught Postgraduate Master's Scholarships you MUST:

- have received an offer to study one of our full-time, campus-based, Taught
 Postgraduate Master's courses in one of the three faculties outlined above for the entry year 2025/26; and
- applied for the scholarships before the final application deadline 23:59 (GMT +1) 11th June 2025, OR 23:59 (GMT+1) 7th April 2025 in the case of the GREAT Scholarships, Bath India Master's Scholarships, Bath Indonesia Master's Scholarships and Bath Vietnam Master's Scholarships, OR 23:59 (GMT+1) 31 May 2025 in the case of the Euromasters Scholarship.

If you have not complied with the conditions outlined above, you will not be considered for any Taught Postgraduate Master's Scholarships (as applicable).

3. Current Scholarships

Taught Postgraduate Master's Scholarships available for 2025/26:

To be considered for a scholarship you must meet the eligibility criteria outlined in section 2 above. Please note that all awards are discretionary and limited in number, so even if you meet the criteria you are not guaranteed to receive one. Successful candidates are selected by the University as outlined below.

Deans Award for Academic Excellence

There are 24 (8 per faculty) Deans Awards worth £5,000 each towards the successful applicant's tuition fees. To be considered for one of these scholarships you must meet the eligibility criteria outlined in Section 2 above.

Global Leaders Scholarship

There are 63 Global Leaders Scholarships worth £5,000 each towards the successful applicant's tuition fees. To be considered for one of these scholarships you must meet the eligibility criteria outlined in Section 2 above.

Frank Wallace Scholarship | Faculty of Engineering & Design | People's Republic of China The Frank Wallace Scholarship is worth £2,500 towards the successful applicant's tuition fees. To be considered for this scholarship you must meet the eligibility criteria outlined in Section 2 above. You must also:

- currently reside in the People's Republic of China
- hold an offer for one of the following programmes for 2025 entry
 - MSc Automotive Engineering with Business Management
 - MSc Automotive Engineering with Electrical Propulsion
 - MSc Automotive Technology
 - MSc Automotive Technology with Business Management

<u>Sir Jack Cater Scholarship</u> | Hong Kong graduates

The Sir Jack Cater Scholarship is worth £3,000 towards the successful applicant's tuition fees. To be considered for this scholarship you must meet the eligibility criteria outlined in Section 2 above. You must also:

• be a graduate from one of the following universities: Hong Kong University, The Chinese University of Hong Kong (CUHK), Hong Kong Baptist University

GREAT Scholarships | China, India, Mexico, Italy, Turkey

There are 4 British Council GREAT Scholarships available for full-time taught master's applicants. The GREAT China, India, Mexico, Italy and Turkey scholarships are available for any subject area, excluding MBA. To be considered for these scholarships you must meet the eligibility criteria outlined in Section 2 above. You must also:

be of Overseas fee status

The scholarships will be awarded per region as outlined below:

- China; 1 award of up to £10,000 for Chinese Nationals and Passport Holders
- India; 1 award of up to £10,000 for Indian Nationals and Passport Holders
- Mexico; 1 award of up to £10,000 for Mexican Nationals and Passport Holders
- Italy; 1 award of up to £10,000 for Italian Nationals and Passport Holders
- Turkey; 1 award of up to £10,000 for Turkish Nationals and Passport Holders

Bath India Master's Scholarships | India

There are 32 Bath India Master's Scholarships available for full-time taught master's applicants. The Bath India Master's Scholarships are available for any subject area, excluding MBA. To be considered for these scholarships you must meet the eligibility criteria outlined in Section 2 above. You must also:

- be of **Overseas** fee status
- be permanently resident in India

Bath Indonesia Master's Scholarships | Indonesia

There are 6 Bath Indonesia Master's Scholarships available for full-time taught master's applicants. The Bath Indonesia Master's Scholarships are available for any subject area, excluding MBA. To be considered for these scholarships you must meet the eligibility criteria outlined in Section 2 above. You must also:

- be of **Overseas** fee status
- be permanently resident in Indonesia

Bath Vietnam Master's Scholarships | Vietnam

There are 6 Bath Vietnam Master's Scholarships available for full-time taught master's applicants. The Bath Vietnam Master's Scholarships are available for any subject area, excluding MBA. To be considered for these scholarships you must meet the eligibility criteria outlined in Section 2 above. You must also:

- be of **Overseas** fee status
- be permanently resident in Vietnam

Euromasters Scholarship

There is 1 Euromasters Scholarship available for full-time taught master's applicants. To be considered for this scholarship, you must hold an offer of study for either:

- MA Contemporary European Studies: Politics, Policy and Society (Euromasters)
- MA Contemporary European Studies with Transatlantic Track (Euromasters)

4. Application

You must apply using the application form link provided in your application tracker. For the Euromaster's scholarship, you must apply using the online application form. If you have any issues or need any assistance, please contact the International Student Recruitment Office at postgraduate-taught-funding@bath.ac.uk.

It is the University's responsibility to identify potential scholarship recipients on the basis of information provided in your scholarship and study application. The University cannot be responsible for any errors or omissions in the information supplied to it and on which eligibility decisions are based. The University's decision on the interpretation of eligibility criteria is final and there is no right of appeal. You must comply with all requests for additional information to establish your eligibility in the timeframes specified and you must submit any evidence requested by deadlines.

Changes to study

If you change to a non-eligible course or mode of study then your Scholarship may be withdrawn. If you make any changes to your original course of study you must notify the International Student Recruitment Office about this as it may affect your continued eligibility.

Suspensions and withdrawal from studies

If you suspend or withdraw from your studies then you will not be eligible to receive any future payments in that academic year and your fee waiver will be re-calculated.

All scholarships paid will be calculated on a pro rata basis and any overpayments may need to be repaid to the University should you suspend, withdraw from studies, transfer to a non-eligible course, or no longer be eligible for a particular scholarship for any other reason. In such a case, the University may seek to recover the amount of the overpayment.

Repeating, extending or deferring your studies

The scholarships outlined here will not be paid during any extension/repeat period(s) to your programme. You may be able to apply for <u>Financial Support Funds</u> from the Student Money Advice Team should you find yourself in financial difficulty. Please note that awards from this fund are not guaranteed.

The scholarships outlined here are for 2025 entry only. If you defer or withdraw and restart, any scholarship already offered will become void. If eligible, you may be considered for support the following year, but this will be subject to the terms of those scholarships then in force. There is no guarantee that postgraduate students will be eligible for funding in future years.

Changes to your immigration status

If you have a change to your immigration status, you MUST notify the International Student Recruitment Office immediately. We may require you to provide documentary evidence of your change in status.

If you receive notice that you are liable to be detained by the UK Home Office then your scholarship will be suspended for the duration of your detention. The University will review the support available to you to help you resume your studies if your status enables you to continue.

Disciplinary action and fraudulent applications

The University reserves the right to terminate your scholarship award and to seek repayment of any sums that have already been set off against your tuition fees in the case of any disciplinary action being taken against you. Cases will be considered on an individual basis by the Head of International Student Recruitment.

The University reserves the right to withdraw a scholarship from anyone who is found to have misled the University about any aspect of their eligibility and to seek repayment of any sums that have already been set off against their tuition fees. In such cases, the University may seek to recover any money paid as a debt in the county court (in which case it may also seek to recover additional sums such as interest, court fees and legal costs). We may request at any point, for audit purposes, evidence of the criteria as stated in your application.

Additional Terms and Conditions

- If a scholarship is awarded to a conditional offer holder, then any scholarship will also be conditional on the student achieving the conditions of entry.
- Please also ensure that you keep your email address up to date in your Bath Application
 Tracker as you may also receive email alerts about our scholarships provision. It is a

- requirement that the home email address provided is your personal email address and not the address of an educational representative or agent.
- Please note that the University does not award scholarships in order of application and does not start selection until after the relevant closing date.
- All awardees may be expected to participate in publicity for the scholarships from time to time during the academic year.
- You cannot be considered for an award if you have not submitted your application along with any appropriate evidence by the published deadlines.
- Awards cannot be claimed retrospectively.
- Feedback will not be provided on unsuccessful applications or decisions on awarded scholarships in any circumstances.
- Only awardees will be notified of a successful scholarship award.
- If you already have a partial scholarship from another organisation (including another
 University of Bath scholarship) for part of your tuition fees, you can combine these
 scholarships, provided that it does not equal more than the cost of your tuition fees.
 However, we will not give a University of Bath scholarship to anyone who already has a full
 scholarship (from another organisation) to pay for their tuition fees. If your financial situation
 changes the University reserves the right to reconsider the award.
- The University reserves the right to review application closing dates to ensure the allocation of awards is met in full.
- We may request at any point, for audit purposes, evidence of any criteria as stated in your application.
- Scholarships cannot be deferred and are for the 2025/26 academic entry year only.
- The University reserves the right to vary the amount of the award and number of awards available from time to time.
- No additional information can be added, nor amendments made, to the original application.

5. Selection

Selection will be based on your answers submitted to questions in your scholarship application, and other contextual information as provided in your application to study at Bath. A selection panel will meet to decide upon allocation of scholarships. This panel will normally comprise the International Student Recruitment Project Delivery Manager, Head of International Student Recruitment and the International Student Recruitment Manager. Scholarship decisions will be made at their discretion and their decision is final. You cannot be considered for an award if you have not submitted a scholarship application along with any relevant supporting evidence, before the relevant application deadline outlined in Section 2. All awards are discretionary and limited in number, so even if you meet the criteria you are not guaranteed to receive one.

6. Definitions

The following definitions apply:

Overseas student means

those students who are classed as overseas and assessed as such for fees purposes.

Home student means

those students who are classed as Home (UK) (England, Wales, Scotland or Northern Ireland), and assessed as such for fees purposes.

7. Appeals

There is no right of appeal and the University's decision is final in relation to your eligibility for a scholarship. You may make a complaint if you believe that you have not been considered for a scholarship because of a procedural error, or you believe that there has been some other procedural problem with our allocating and awarding system. Complaints should be made in writing to the International Student Recruitment Office by emailing postgraduate-taught-funding@bath.ac.uk.

8. Use of Data

The University may use the data/information you share with us as part of your application, to provide information and advice about the University to you as an applicant. Should you subsequently join the University, the University may also use the data you provide to inform our strategies for supporting you as a new entrant, to inform you about provision that you may be able to access, to monitor student success and for other legitimate reasons. All awardees may be expected to participate in publicity for the scholarships from time to time during the academic year. In the case of scholarships which are funded by a corporate or private donor, personal details may be passed to this third party to assist them to administer the award.
